

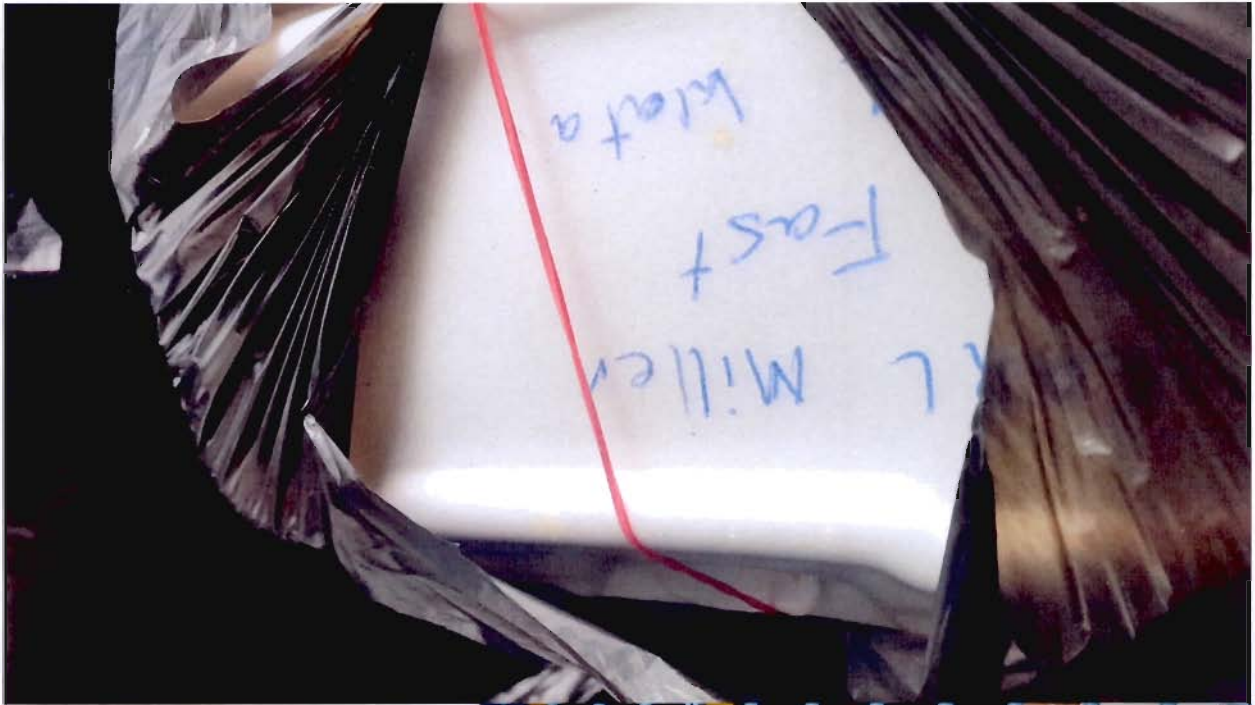

Obtaining money under false pretence	-	(a fine or up to 5 yrs imp.)
Immigration Act, Breach of/ Over Staying in the Country	-	(fine of \$10,000 or 3yrs imp.)
